The data they collect help provide large-scale beekeepers with the knowledge to make management decisions to maintain healthy colonies.

Emergency Response Kits, Sentinel Apiaries Other Programs - We maintain across a wide range of disciplines including traditional honey bee science, economics, statistics, and medical research that makes all these tools available to this important research. We learn more by studying honey bee health on a large scale than we can in individual lab experiments. Borrowing traditional methods of cancer research from human medicine, we gather huge amounts of data submitted by beekeepers to understand just two things: How many hives they lost last season and how they kept their bees during that season.
